Accelerate development & implementation of healthcare solutions





## biovia

- Call twice a year (except for feasibility studies, which can be submitted throughout the year)
- Three organizations in consortium of research & development projects (incl. ICON)
- Supported by our innovation team

- Value-based healthcare & efficiency
- Therapeutics, diagnostics & monitoring
- Prevention
- Sustainability

### 2025.2 call - Key criteria


- Grant options: Feasibility / O&O
   / ICON / TETRA / COOCK+ /
   (only 1 cSBO available in 2026)
- Match Biovia criteria & strategy (next slide)
- Match VLAIO grant criteria (see VLAIO website) & impact criteria (next slide)

### 2025.2 call - Support

- Up-front sparring with Biovia and VLAIO to:
  - validate strategic match
     & grant type
  - receive support for next steps
- Shorter project process flow for feasibility study



# All grants need to also match the Biovia strategy & criteria and VLAIO impact criteria\*

### Biovia strategy & criteria


- Innovation involves cross-over activities
- At least 2 out of 3 domains are involved
  - Medical biotech
  - Digital health
  - Medtech
- Biovia members are involved

### **VLAIO** impact criteria

- Economic leverage by factor 10 (forprofit organizations)
- Societal valorization for recognized healthcare institutions

# Grant options 1. Biovia consortium feasibility

### Feasibility study

- Preparation of ambitious fundable, innovative follow-up trajectory (within or outside VLAIO funding channels)
- Simple approval process
- Not a small R or D project
- Can be the start to build confidence for a larger R&D project / ICON

#### **Biovia criteria**


 Consortium consists of min. 3 companies of which 2 in Flanders and 2 members of Biovia

#### **NOTE**


- Feasibility studies and development project < €500k</li>
   subsidy = > no evaluation by external experts (in general)
- Feasibility project: max. 1 yr, €50k/partner

## Grant options 2. Biovia consortium R&D

#### Research project

- Build new expertise and skills using systematic approach
- Goal: to use new knowledge to develop new products, processes or services or significantly improve existing ones


#### **Development project**

- Use existing knowledge, expertise and skills
- Goal: to create plans, designs and prototypes of new, altered or improved products, processes and services

#### **NOTE**

- Research project: max. 3 yrs, €100k €3m
- Development project: max. 2 yrs, €25k €3m

# Grant options 2. Biovia consortium R&D

### Eligibility for funding

#### **VLAIO** criteria

- Funding limited to Flemish partners
- Research partners paid in full by others
- No OIM (enterprise in difficulty) at time of submission
- Innovative Starter Subsidy: Not to be cumulated with R&D

#### **Biovia criteria**

Consortium consists of min. 3 companies (for-profit or non-profit) of which 2 in Flanders and 2 members of Biovia

#### **VLAIO** funding for Flemish partners

Companies: 25% ... 60% subsidy/partner

- Funding limited to Flemish partners

- Hospitals are considered as non-profit industry
- Min. 3 industry (for/non-profit)
- Min. 2 Flemish industry (for/non-profit)
- Min. 1 Biovia member
- All partners (for/non-profit)
   <70% of total project budget</li>

# Grant options 3. Biovia cluster SBO (cSBO)


#### **NOTE**

- Only 1 cSBO in 2026: proposal needs to be developed in close collaboration with Biovia and align strongly with Biovia themes
- Before submitting an intent to submit, a sparring session with Biovia needs to be planned

### **Specifics**

- Independent, innovative research with the potential of economic or societal applications
- Goal: building new knowledge in order to start a dialogue between research centers and enterprises
- Projects that fit within the MEDVIA trajectory, results will contribute to the strategic roadmap of MEDVIA
- Need for a 'begeleidingscommissie' (advisory committee)

# Grant options 3. Biovia cluster SBO (cSBO)

### Eligibility for funding

#### **VLAIO** criteria

- At least 2 research groups of at least 1 Flemish research institute
- Imec, VITO, VIB, Flanders Make, VLIZ, UC: in collaboration with at least 1 research institute
- Hospitals = companies

#### **Biovia criteria**

- Research partners in the consortium are Biovia members
- Min. 3 members of Biovia in advisory committee

#### **NOTE**

- 4 yrs
- 100% subsidy
- Max. 500 k€/legal entity/year
- Max. 3M€
- Companies: subcontractor

# Grant options 4. Biovia consortium ICON

### **Specifics**

- Combination of strategic, basic research (SBO) (research institute) + R&D project (enterprises)
- Independent, innovative research with the potential of economic or societal applications (part knowledge institute, SBO part) + research / development (part enterprises)
- Goal: building new knowledge and starting a dialogue between research centers and enterprises
- Projects that fit within the Biovia trajectory, results will contribute to the strategic roadmap of Biovia
- Need for a begeleidingscommissie (advisory board) for the SBO part of the project

#### **NOTE**

- Duration 2-4 years
- Max. €3m for company
- Budget research partner: see cSBO

## Grant options 4. Biovia consortium ICON

### Eligibility for funding

#### **VLAIO** criteria

- Min. 3 industry partners
- Min. 1 research group from a Flemish research organization
- Imec, VITO, VIB, Flanders Make, VLIZ, ILVO, INBO: in collaboration with at least 1 other research organization
- Mandatory dissemination by research partner
- No OIM Partners at moment of submission
- No cumul with Innovative Starter Subsidy

#### Biovia criteria


- Research partners in the consortium are Biovia members
- Consortium consists of min. 3 companies (for or non-profit),
   of which 2 in Flanders and 2 members of Biovia

#### **VLAIO** funding for Flemish partners


- Companies: 25% ... 60%
- Research partners: 100%

# Grant options 5. Biovia COOCK+



(\*) See call description for more details



### **Specifics**

- Translation and valorization of research results by accelerating the introduction of technology and/or knowledge to a large group of organizations
- Final results need to benefit (a specific part of) the Biovia ecosystem
- Part A: funded
- Part B: organization-specific actions to evaluate knowledge, analyze, test
- Projects can involve some research, but cannot compromise dissemination

# Grant options 5. Biovia COOCK+

### Eligibility for funding

#### **VLAIO** criteria

- 1 or more organization(s) for research and knowledge
- Advisory Board (mostly SMEs) with min. 5 Flemish organizations and strong involvement
- Part A (generic) / Part B (organization-specific)

#### **Biovia** criteria

- Main applicant is member of Biovia
- Advisory committee should be representative and actively involved in the project to stimulate knowledge transfer
- Min. 3 members of Biovia in advisory committee

#### **VLAIO** funding for Flemish partners

- 50%-100% subsidy
- Company: subcontractor (specific expertise)
- 1-3 years
- Max. €1m

# Grant options 6. Biovia TETRA

### **Specifics**

- Translation of recently available knowledge into concrete, useful information so that the target group can innovate faster and more efficiently
- Need for economic finality (to be translated into competitiveness, employment and investments in enterprises in Flanders). In addition, the project can address a societal challenge
- Fit with the educational assignment of the applicant(s)

# Grant options 6. Biovia TETRA

### Eligibility for funding

#### **VLAIO** criteria

- Research group from a Flemish university and/or universitycollege actively engaged in practice-based research
- Advisory committee with strong involvement

#### Biovia criteria

- Main applicant is member of Biovia
- Min. 3 members of Biovia in advisory committee

#### **VLAIO** funding for Flemish partners

- 92,5% subsidy
- Max. €480k
- 2 years


## General remarks for all grant types

- Enterprise in difficulty: check at time of submission
- No cumulation of Innovative Starter Subsidy
- For companies involved in different project applications (or already involved in ongoing VLAIO projects) => check if realization of the work in the different projects is feasible
- Each of the partners needs to have an own contribution that can be subsidized (own knowledge increase <u>and</u> challenges); consider this carefully whether you are a partner or subcontractor
- Think about the possibility for feasibility studies
- Projects working with health data => think carefully about the legal frameworks (incl. Data Act) and how to integrate / work with EHDS





<sup>\*</sup>A success fee of €3,500 (excl. VAT) per organization in the consortium applies **exclusively to non-members of Biovia. Members of Biovia are exempt from the success fee.** To be considered a member of Biovia, an organization is a member both at (1) the time of Full Proposal submission in the VLAIO KRIS portal and (2) the time of approval of subsidy by VLAIO.




